The goal of the Collaborative is to leverage significant federal funds to reduce emissions from the most polluting diesel sources in the most affected communities. The Collaborative seeks to significantly improve air quality and public health by targeting the highest polluting engines with the most cost effective control strategies. The Collaborative is one of the first pilot projects of the National Clean Diesel Campaign.

#### Important Events in Congress

As many of you are already aware, there has been quite a bit of activity with the US Congress on the voluntary diesel emission reductions programs. For the first time ever, the West Coast Collaborative was appropriated \$3 million (which is double what we granted last year using discretionary funds) within EPA's FY06 budget under the auspices of the National Clean Diesel Campaign. In addition, there were over \$450 million in authorizations to reduce diesel emissions in the Energy Bill and amendments to the CMAQ program and the Surface Transportation Fund that will encourage diesel retrofits and idle reduction.

Many of the non-federal government Collaborative members have subsequently been involved in US congressional advocacy efforts to appropriate \$200 million in the FY07 budget. These advocates included Caterpillar, Environmental Defense, STAPPA/ALAPCO and various state and local air agencies, Union of Concerned Scientists, American Trucking Association and the American Association of Port Authorities, to name a few. This group collected signatures for a letter to the President and the 3 Governors of California, Washington, and Oregon sent a letter as well.
